ADMISSION

The admissions procedure for the University Master in Law: European Union Studies consists of two stages: pre-registration and official registration.

The process of integrating the system of university studies in Spain within the European Higher Education Area and the European Research Area, forms part of the objective of making Europe a standard bearer of quality education. In light of the transformation this process has brought about in relation to undergraduate and postgraduate studies in Spain, Article 2 of Decree-Law 56/2005 (21 January) governing postgraduate university studies, states that: **'The aim of official postgraduate studies is the specialisation of knowledge [...] These studies will take the form of programmes of instruction leading to the degree of Master or Doctor.'**

The implementation of the UDC's University Master in Law: European Union Studies was ratified by Decree - Law 51/2006 (23 March) of the Department of Education of the Regional Government of Galicia (DOG nº61, 28 March), and approved by the Galician Universities Council on 1 June 2009. The course curriculum was published in the BOE Nº15 (18 January 2012).

> OBJECTIVES

The objective of the University Master in Law: European Union Studies is to provide graduates with specialised, multidisciplinary advanced training in a range of subjects concerning different aspects of the European Union, with particular emphasis on training professionals for European public administration and resource management.

> CAREER OPPORTUNITIES

The Master's programme has been created in response to the growing demand across a range of sectors for professional graduates with this type of training, particularly in public administration – local, regional, national and EU; in business, and among other social, economic and legal operators in the EU Internal Market and the euro area, all of whom are bound by the EU Law.

The course provides an excellent foundation for students considering sitting an EU entrance exam in the future. The programme also offers an extra-curricular work placement option in public institutions and private companies.

Students who complete the University Master in Law: European Union Studies will be entitled to continue their studies to PhD level under the UDC PhD Programme.

> STUDENTS

Open to students with a Bachelor's degree or equivalent (Spanish and non-Spanish).

> QUALIFICATION AWARDED

Official University Master in Law: European Union Studies, by the University of A Coruña.

> TEACHING STAFF

Teachers from Spanish and foreign universities, together with other renowned experts in the field of EU Law.

> DURATION AND ORGANISATION

The University Master in Law: European Union Studies degree will be awarded to students who obtain a minimum of 60 ECTS, to be distributed as follows:

> First Term (Core Part: 30 core ECTS) and
> Second Term (Specialisation Part: 20 subject ECTS and 10 ECTS from research, language training and Research Dissertation activities).

The academic year will begin in September 2014 and end in July 2015. Classes will be held in the Faculty of Law of the University of A Coruña, with the "Salvador de Madariaga" University Institute of European Studies and European Documentation Centre (CDE) providing support for additional learning activities and seminars. Availing of the University's Master Erasmus Exchange agreement with the University of Louvain (Belgium), students will also have the opportunity to visit the institutions of the EU as part of a special field trip arranged for them by the Coordination team of the Master programme.

> INTERNSHIP PROGRAMME

At the end of the Master course, students may apply for one of the paid or unpaid internships offered by a number of programme-partner public institutions and private companies.

Course fees in accordance with the terms established by Decree-Law of the Department of Education and University Planning of the Regional Government of Galicia (early admissions 2013/2014: €21.61/ECTS; standard admission: €26.68/ECTS).

General selection criteria:
